8.		Mr.X, Mr. Y and Mr.Z were partners in a partnership firm M/s.XYZ& Co., which is engaged in the business of trading branded furniture. The name of the partners was clearly written along with the firm name in front of the head office of the firm as well as on the letter-head of the firm. On 1 <sup>st</sup> October 2019, Mr. Y passed away. His name was neither removed from the list of partners as stated in front of the head office nor from the letter-heads of the firm. As per the terms of the partnership, the firm continued its operations with Mr.X and Mr.Y as partners. The accounts of the firm were settled, and the amount due to the legal heirs of Mr.Z was also determined on 10 <sup>th</sup> October 2019. But the same was not paid to the legal heirs of Mr.Z on 16 <sup>th</sup> October 2019. Mr. A, a supplier, supplied furniture worth 20,00,000 to M/s XYZ & Co. could not repay the amount due to heavy losses. Mr.X wants to recover the amount not only from M/s XYZ & Co., but also from the legal heirs of Mr.Z. Questions:	12M
